We offer franchises for the establishment and operation of My Eye Lab® stores. A My Eye Lab® store is a unique optical retail store and examination facility. The franchise includes a proprietary and well-established system that eliminates the need for an on-sight lab.

The total investment necessary to begin operation of a single My Eye Lab® franchise ranges from \$407,477 to \$585,543. This includes \$221,027 - \$271,393 that must be paid to us or our affiliates for an initial franchise fee and for signage, furniture, fixtures, and equipment. If you enter into an Area Development Agreement to develop multiple units, your initial investment will range from \$407,477 to \$585,543 for each franchise unit that you commit to opening.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

OUT OF STATE MEDIATION AND LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE RESOLUTION FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE OR LITIGATE WITH US IN FLORIDA THAN IN YOUR HOME STATE.
2. THE FRANCHISE AGREEMENT AND AREA DEVELOPMENT AGREEMENT STATE THAT FLORIDA LAW GOVERNS THE AGREEMENT, AND FLORIDA LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS YOUR STATE'S LAW. YOU MAY WANT TO COMPARE THESE LAWS.

We pay these persons a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
