A My Gateway Tax Service franchised business offers tax preparation services, year-round national tax service specializing in computerized federal and state preparation of individual returns, and other financial and related products.

The total investment necessary to begin operation of a My Gateway Tax Service Office Storefront Franchised Business is \$33,600 to \$53,700. This includes \$20,000 that must be paid to the franchisor and its affiliate(s).

The additional total investment necessary to begin operation of a My Gateway Tax Service Area Developer Franchise is \$10,000 to \$50,000. This includes \$10,000 to \$50,000 that must be paid to franchisor and its affiliate(s). You must open a minimum of one additional My Gateway Tax Service Franchised Business under an Area Development Agreement.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
