We offer qualified individuals and entities a franchise for the right to independently own and operate a facility that provides its patrons with certain personal and group fitness training and nutritional guidance services that we authorize, which are typically provided on a per-class basis, utilizing our proprietary marks and business system (each, a 'Franchised Business' or "Facility") We also offer qualified parties the right to own and operate multiple Facilities within a development area that we designate

The total investment necessary to begin operation of a single Facility ranges from \$96,750 to \$179,875. This includes \$59,800 that must be paid to us or our affiliates.

The total investment necessary to operate multiple Facilities under our form of area development agreement depends on the number of franchises we grant you the right to open. The total investment necessary to enter into a development agreement for the right to develop three (3) Facilities is \$172,250 to \$255,375, which includes a \$125,000 development fee that is paid to us and your total investment to begin operation of your initial MY HOUSE FITNESS Facility. Under the area development agreement, the initial development fee is calculated as follows:

(i) \$125,000 for the right to open three Facilities, plus an additional \$41,667 for the right to open each additional Facility (up to a total of five), (ii) \$35,000 per Facility if you agree to open and operate between six and nine Franchised Businesses and (iii) \$30,000 per Facility if you agree to open and operate 10 or more Franchised Businesses.
