The Franchisee will own and operate a Nancy's Pizza Restaurant which offers for sale to the general public a variety of pizza, pasta, sandwiches and other approved menu items using the service marks and trade secrets owned by or licensed to Chicago Franchise Systems, Inc.

The total investment necessary to begin operation of a Nancy's Pizza "Carry Out" and Delivery Restaurant franchise is from \$347,500 to \$464,000. This includes \$30,000 franchise fee that must be paid to the Franchisor. The total investment necessary to begin operation of a Nancy's Pizza, full service restaurant franchise is from \$582,500 to \$770,000. This includes the \$30,000 franchise fee that must be paid to the Franchisor.

If the Franchisee wishes to develop multiple franchises within a certain geographic area and act as a Business Manager within that geographic area, the Franchisee will also pay the Franchisor an area development/business manager fee ranging from \$10,000 to \$300,000 depending upon the size, population density and location of the development area and the number of Nancy's Pizza Restaurants to be developed. In such event, the range of the total amount necessary to begin operation of a Nancy's Pizza franchise is from \$357,500 to \$764,000 for a "Carry Out" and \$592,500 to \$1,070,000 for a full service restaurant.

This Franchise Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Franchise Disclosure Document and all accompanying agreements carefully. You must receive this Franchise Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to the Franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
