The Franchise offered is a NATIONAL PROPERTY INSPECTIONS franchise that provides residential and commercial inspection related services to prospective buyers, lenders, insurance companies, field service companies and other interested parties. The purchase of the franchise system includes training in the building and operation of an inspection business, training in sales and marketing, tools and equipment, computer, training materials, training in electrical, mechanical, plumbing, varied inspection techniques and the like.

The total investment necessary to begin operation of a National Property Inspections franchise is \$39,550 - \$42,000. This includes the \$32,900 franchise fee that must be paid to the franchisor or affiliate.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.** If you learn that anything in this offering circular is untrue, contact the Federal Trade Commission.

The terms of your contract will govern your franchise relationship. Don't rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this Disclosure Document can help you make up your mind. More information on franchising, such as *"A Consumer's Guide to Buying a Franchise,"* which can help you understand how to use this Disclosure Document, is available from the Federal Trade Commission.
