The franchise offered is for the operation of a private occupational school to educate and train prospective dental assistants.

The total investment necessary to begin operation of a National School of Dental Assisting franchise (see Items 5 and 7) is estimated to range from \$23,575 to \$33,000. This includes \$9,900 that must be paid to the franchisor or affiliate.

You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
