The franchise offered is a specialty retail beauty business offering waxing hair removal services, skin care services, spa services, and related services and products. The total initial investment necessary to begin operation of a NATURA WAXING LOUNGE & SPA franchise store is from \$77,900 to \$286,100. This includes \$20,000 to \$27,000 paid to the franchisor.
