## NATURAL REJUVENATION MEDSPA

The franchised business is to operate a skincare and rejuvenation spa under the trade name Natural Rejuvenation MedSpa.

The total investment necessary to begin operation of a Natural Rejuvenation MedSpa franchise is \$108,000 to \$358,200. This includes the \$40,000 franchise fee and \$3,000 to \$6,000 for certain equipment and inventory that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.** 

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.
