Neaumixfit Franchise LLC ("we," "us," or "our") offers for sale a franchise to operate a fitness studio offering a mix of Pilates, TRX, Cycle, Barre and Yoga, and other exercise programs through live instructional group and individual classes (the "Neaumixfit Studio"), identified by the trade name "Neaumixfit" and related marks.

The total estimated investment necessary to begin operations of a Neaumixfit Studio franchise ranges from \$108,700 to \$235,500. This amount includes \$29,500 that must be paid to the franchisor. The total investment necessary to begin operation of a Neaumixfit Studio franchise pursuant to a three-unit Area Development Agreement is \$141,150 - \$267,950. This includes \$61,950 that must be paid to the franchisor.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read the disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payments to the Franchisor in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

Initial Franchise Fee shall be fully earned by Franchisor upon payment and is not refundable, in whole or in part, under any circumstance.

Founder's Club-Discount Program

— During our initial period of offering franchises for sale, we will offer founding franchisees a 50% discount on the initial franchise fee (the "Founder's Club Discount Program"). We reserve the right to extend the time limit for offering the Founder's Club Discount Program. The Founder's Club Discount Program will only apply to a new franchisee's first Neaumixfit Studio franchise; the discount is only available on one franchised business, it is not applicable for a discount on an area development agreement. This program is not intended to supplement or amend the Franchise Agreement or any other agreement and does not create any additional rights for Franchisee or any third party.

Area Development Agreement

If you wish to develop 3 or more Neaumixfit Studios, you will sign an Area Development Agreement. Upon execution of the Area Development Agreement, you will pay us a lump sum development fee (the "Development Fee") for the 3 (or more) Neaumixfit Studios to be developed under the Area Development Agreement. The Development Fee is not refundable, in whole or in part, under any circumstances. The amount of the Development Fee will be equal to the Initial Franchisee Fee (i.e., \$29,500) times the number of Neaumixfit Studios to be developed under the Area Development Agreement less a 30% discount. For example, the Development Fee for 3 Neaumixfit Studios would be \$29,500 x 3 = \$88,500) - 30% = \$61,950.

The Initial Franchise Fee for each Neaumixfit Studio developed under an Area Development Agreement will be reduced by 30%. The Development Fee will be credited to the Initial Franchise Fee when you sign the Franchise Agreement for each Neaumixfit Studio, such that no further amount is due and owing by you to us in connection with any or all of the Neaumixfit Studios developed under the Area Development Agreement.

New York and Oklahoma require that we give you this Disclosure Document at the earlier of the first personal meeting or 10 business days before the execution of the franchise agreement, or other agreement, or the payment of any consideration that relates to the franchise relationship.

Michigan, Oregon and Wisconsin require that we give you this Disclosure Document at least 10 business days before the execution of any binding franchise agreement, or other agreement, or the payment of any consideration, whichever comes first.

If Neaumixfit Franchise LLC does not deliver this Disclosure Document on time or if it contains a false or misleading statement, or a material omission, a violation of federal and state law may have occurred and should be reported to The Federal Trade Commission, Washington D.C. 20580 and the appropriate State Agency identified on Exhibit B.
