We offer NECTIRTM franchises, which will operate a NECTIRTM temporary staffing and personnel service that offers temporary staffing and personnel services in several categories of industries.

The total investment necessary to begin operation of a NECTIRTM franchise business ranges from \$71,810 to \$128,650 for a start up franchise and \$47,210 to \$123,650 for a qualifying conversion franchise. This includes \$30,000 for a new franchise, and \$7,000 to \$25,000 if a qualifying conversion franchise, that must be paid to the franchisor for your first Franchise Service category. For a qualifying conversion franchise with annualized gross revenues of \$1 million - \$3.99 million, the Initial Franchisee Fee is calculated at 0.35% of annualized gross revenue of the current staffing business; with annualized gross revenues of \$4 million or greater, the Initial Franchisee Fee is calculated at 0.25% of annualized gross revenue of the current staffing business

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this document at least fourteen (14) calendar days before you sign a binding agreement with, or make any payment to, the franchisor, its parent or an affiliate in connection with the proposed franchise sale. Note, however, no governmental agency has verified the information contained in this document.

- 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY LITIGATION/MEDIATION ONLY IN TEXAS. OUT-OF-STATE LITIGATION/MEDIATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES, IT MAY ALSO COST YOU MORE TO LITIGATE /MEDIATE WITH US IN TEXAS THAN IN YOUR OWN STATE.

- 4. THIS IS A DEVELOPMENTAL FRANCHISE SYSTEM. THE NECTIRTM STAFFING SERVICES FRANCHISE IS OFFERED BY A DEVELOPMENT STAGE COMPANY.
- 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We may use the services of one or more franchise brokers or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
