The franchised business is to operate a technology sales, repair and service business under the trade name “NerdsToGo,” offering a wide variety of computer technology services and products primarily to residential computer users and small and medium-sized businesses. Technicians based in “NerdVans” serve customers at their residences or place of business.

We offer two franchise models. In the “Executive Office Model”, your business will be based out of an office space, and will not have a walk-in customer facing area. In the “Local Service Center Model”, your business will be based out of a visible retail center, and you will have a stronger emphasis on walk-in customers.

The total investment necessary to begin operation of an Executive Office Model NerdsToGo franchise is \$148,900 to \$285,700. This includes \$75,000 to \$100,000 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of a Local Service Center Model NerdsToGo franchise is \$199,000 to \$333,900. This includes \$75,000 to \$100,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
