The Franchisee will operate one or more retail stores which sell a full line of take-out bagels (baked on premises), gourmet coffees, gourmet sandwiches, wraps, salads and offers meeting and luncheon catering. The estimated total investment necessary to begin operation of a single New York City Bagel & Sandwich Shop (the "Franchise") store ranges from \$118,500.00 to \$208,000.00. This includes \$29,500 that must be paid to the Franchisor or the Franchisor's affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

The terms of your franchise agreement will govern your franchise relationship. Don't rely on the disclosure document alone to understand your franchise agreement. Read all of your franchise agreement carefully. Show your franchise agreement and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind.
