A Next Day Access[®] franchisee will engage in the sale and rental of ramps and additional related products and accessories that enhance the quality of life of physically disabled or challenged persons (the –Next Day Access[®] Franchise" or the –Fanchised Business").

The total investment necessary to begin operation of the Franchised Business is \$85,525 – \$112,900, which includes \$42,500 to \$45,700 that must be paid to us or our affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
