The franchised business is to operate car wash and detailing services under the trade name “No-H2O” The franchised business will incorporate both a fixed or static location which is operated from a small retail location and an on-demand services business where you provide onsite car wash and detailing services

The total investment necessary to begin operation of a No-H2O franchise is \$337,600 to \$365,500 This includes \$80,600 to \$332,000 that must be paid to the franchisor or affiliate
