American Immigration Center Franchise LLC, a California limited liability company, offers franchises for the operation of an American Immigration Center business, which counsels individuals on immigration to the United States under the trade name and service mark "American Immigration Center." We offer the rights for 2 different franchises in this Disclosure Document:

Single Franchise Program. Under the Single Franchise Program, you will sign a Franchise Agreement to operate one American Immigration Center business. The total investment necessary to begin operations of one American Immigration Center business ranges from approximately \$38,700 to \$87,000. This includes \$10,000 that must be paid to us or our affiliates.

Area Development Program. Under the Area Development Program, we will assign you a defined area within which you must develop and open 2 or more American Immigration Center businesses within a specified period of time. The total investment necessary to begin operations of the first of 2 to 3 American Immigration Center business under an Area Development Agreement ranges from approximately \$44,700 to \$94,000 per business. This includes \$15,000 that must be paid to us or our affiliates.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read the Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payments to the Franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

OUT OF STATE MEDIATION AND LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO PARTICIPATE IN MEDIATION AND LITIGATION WITH AMERICAN IMMIGRATION CENTER FRANCHISE LLC IN THE STATE WHERE WE HAVE OUR PRINCIPAL PLACE OF BUSINESS THAN IN YOUR HOME STATE.
