The total investment necessary to begin operation of a Nothing Bundt Cakes® Bakery is ~~\$361,754~~\$339,800 to ~~\$412,076~~\$440,700, excluding extension fees. This includes ~~\$56,100~~\$45,850 that must be paid to the franchisor and its affiliate.
