The franchise is to operate gourmet bakeries offering and selling specialty bundt cakes, other food items, and retail merchandise under the "Nothing Bundt Cakes®" mark.

The total investment necessary to begin operation of a Nothing Bundt Cakes® Bakery is 361,754339,800 to 412,076,440,700, excluding extension fees. This includes 56,10045,850 that must be paid to the franchisor and its affiliate.

Franchisor also offers an Area Development Agreement for the establishment and operation of multiple Nothing Bundt Cakes[®] Bakeries in a specified development area. The total investment necessary to begin operation of an The Area Development BusinessFee is \$336,675 to \$387,076 for the first Bakery, plus a development fee equal to \$25,000 for the first Bakery developed under the Area Development Agreement and \$1020,000 for each additional Bakery.bakery developed under the Area Development Agreement. The total investment necessary to begin operation of the first Bakery under an area development business is \$339,800 to \$440,700, excluding extension fees. This includes \$56,10045,850 that must be paid to franchisor or an affiliate in connection with opening the first Bakery.
