You will offer and sell a variety of services and customization options for kitchens and bathrooms. You will provide the services and products operating under the Marks and using the System.

The total investment necessary to begin operation of a NuFinishpro franchised business is from \$37,250 - \$70,350. This includes an initial fee ranging from \$25,000 - \$40,000, dependent upon population of Territory, that must be paid to the franchisor.
