The total investment necessary to begin operation of a NutriMost franchise is \$44,645 (low range) to \$77,466.768 (high range). This includes \$26,997 that must be paid to the franchisor.

THIS ROYALTY FEE, WHICH IS PAYABLE MONTHLY AT THE RATE OF \$599 (FOR EACH ZIP CODE) FOR FIVE (5) YEARS, IS DUE WHETHER OR NOT ANY SALES ARE GENERATED BY THE FRANCHISE AND IS PAYABLE EVEN IF THE FRANCHISE AGREEMENT IS TERMINATED.
4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
