The franchise offered is for the right to operate a “Nutrishop Store” franchised business offering sports nutrition, dietary supplements, vitamins, weight loss products, related food items and other products, goods and promotional items (e.g., apparel, clothing, shaker cups and sports items) utilizing the proprietary system for Nutrishop Stores.

The total investment necessary to begin operation of a franchise for a new Nutrishop Store ranges from \$112,000 to \$207,795. This amount includes from \$65,000 to \$80,795 that must be paid to the franchisor or its affiliate.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

IT MAY COST YOU MORE TO ARBITRATE OR LITIGATE WITH US OR OUR AFFILIATE IN THE CITY IN WHICH OUR THEN CURRENT PRINCIPAL BUSINESS ADDRESS IS LOCATED THAN IN YOUR OWN STATE.
