As a Nutty Scientists franchisee, you will offer an entertainment-oriented educational program in almost every area of scientific thought, with the objective of leading children to discover and enjoy science under the Mark "NUTTY SCIENTISTS."

The total investment necessary to begin operation of a NUTTY SCIENTISTS franchised business is from \$52,700 - \$64,100 Home Based and \$163,050 - \$265,100 if a retail Lab space is developed. This includes \$28,000 that must be paid to the franchisor for the initial franchise fee and \$17,000 for the on-site training and equipment package to operate the franchise. Noted in Item 7 is an option to secure additional schools at an additional fee of \$100 per school added to the initial franchise fee.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind.
