The franchisee will own and operate a pizza restaurant under the service mark **NYPD®** and logo design.

The total investment necessary to begin operation of an NYPD Location is \$304,700 to \$789,900. This includes \$35,000 that must be paid to the franchisor or its affiliate; and if we build a commissary serving your location you must pay us for pre-opening inventory, which ranges from \$5,500 - \$12,500. We also offer a Development Agreement, which grants the right to develop multiple restaurants in a specified territory. The Development Fee will be 50% of the total initial franchise fees of the restaurants, after the first restaurant to be developed.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

You may wish to receive your disclosure document in another format that is more convenient for you. The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind.
