This franchise is for the operation of a klosk, cart or inline store located in a shopping mall that sells a proprietary line of reasonably priced sunglasses, reading glasses, and accessories under the "NYS Collection" name and marks.

The total investment necessary to begin operation of a NYS Collection RMU cart is \$19,570-\$63,180. This includes between \$11,250-\$45,000 that must be paid to the franchisor and/or its affiliate, as appropriate. The total investment necessary to begin operation of a NYS Collection Custom Kiosk is \$59,415-\$113,878. This includes between \$13,750-\$50,000 that must be paid to the franchisor and/or its affiliate, as appropriate. The total investment necessary to begin operation of a NYS Collection Inline Store is \$81,415-\$176,378. This includes between \$13,750-\$50,000 that must be paid to the franchisor and/or its affiliate, as appropriate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
