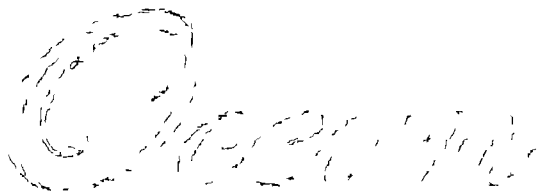

As an Ocean Exteriors franchisee, you will operate a home remodeling company, running sales and installation of products such as roofing, exterior coating, vinyl windows, paving, and other similar home improvements. You will establish relationships with installers that provide services to clients in a given territory.

The total investment necessary to begin operation of an Ocean Exteriors franchised business ranges from \$76,850 to \$91,400. This includes \$34,900 which must be paid to the franchisor or affiliate. The total investment necessary to begin operation of an Area Development Business for three to five outlets ranges from \$111,750 to \$161,200. This includes \$69,800 to \$104,700 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
