This Franchise Disclosure Document is for the sale of an OctoClean franchise. As a Franchisee, you will provide commercial cleaning, maintenance, and janitorial services using the OctoClean System and Marks.

To simplify the language in this Franchise Disclosure Document, the Franchisor, OctoClean Franchising Systems, Inc. is referred to as "we," "our," and "Franchisor." "You" means the company which, buys the franchise, including company's owners, partners, controlling shareholders, and guarantors, if any.

The total investment necessary to begin operation of an OctoClean franchise ranges from \$15,260 to \$124,350. This includes an Initial Franchise Fee that ranges from \$13,500 for Initial Business, as defined below, of \$2,500 per month to \$31,000 for Initial Business of \$10,000 per month that must be paid to the franchisor. This Franchise Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Franchise Disclosure Document and all accompanying agreements carefully. You must receive this Franchise Disclosure Document at least fourteen (14) calendar days before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Do not rely on the Franchise Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Franchise Disclosure Document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this Franchise Disclosure Document can help you make up your mind.
