The franchisee will establish and operate an Office Furniture USA dealership as part of a network of furniture dealers nationwide. The franchisee will promote and sell office furniture and accessories in accordance with proprietary system techniques and standards, advertising and public relations to advance client satisfaction and development.

The total investment necessary to begin operation of an Office Furniture USA dealership ranges from \$61,650 to \$146,250. This includes \$3,500 - \$3,700 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to the franchisor or any affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

BEFORE YOU BUY, CONSIDER WHAT RIGHTS YOU HAVE TO RENEW YOUR FRANCHISE, IF ANY, AND WHAT TERMS YOU MIGHT HAVE TO ACCEPT IN ORDER TO RENEW.

- 1. THE DEALER AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION IN BIRMINGHAM, ALABAMA. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN ALABAMA THAN IN YOUR OWN STATE.
- 2. THE DEALER AGREEMENT STATES THAT ALABAMA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTION AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. THE DEALER AGREEMENT STATES THAT WE MAY TERMINATE THE DEALER AGREEMENT IF YOU FAIL TO PURCHASE THE MINIMUM PURCHASE REQUIREMENTS. SEE ITEM 8.
- 4. THERE MAY BE OTHER RISKS CONCERNING THE FRANCHISE.
