The franchise offered is for the operation of a single unit **OFFICE PRIDE**® janitorial service business that sells and performs janitorial services, related services and ancillary goods in office buildings, retail buildings, medical buildings, commercial buildings, churches and other commercial facilities that require routine contract cleaning to create or maintain a clean work environment. We also offer an area developer franchise program which provides qualified individuals with the opportunity to develop and service the single unit **OFFICE PRIDE**® franchises located in a specified trade area on our behalf.

The total investment necessary to begin operation of a single unit **OFFICE PRIDE**® franchise is from \$14,900 to \$59,000. This includes \$9,900 to \$29,900 that must be paid to us or our affiliates. If you currently operate a commercial cleaning business you may convert your existing business to an **OFFICE PRIDE**® franchise.

The total investment necessary to begin operation of an area developer franchise is from \$147,400 to \$309,000. This includes \$40,000 that must be paid to us.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however that no government agency has verified the information contained in this document.

THE FRANCHISE AGREEMENT REQUIRES THAT ALL DISAGREEMENTS (EXCEPT FOR THOSE RELATED TO YOUR USE OF OUR TRADEMARKS AFTER THE EXPIRATION OR TERMINATION OF THE FRANCHISE AGREEMENT) BE SETTLED BY ARBITRATION, LITIGATION OR THROUGH A PROCESS THAT USES CHURCH AND BIBLICAL PRINCIPLES (WHICH FOLLOW THE TEACHINGS OF JESUS CHRIST AND THE KING JAMES BIBLE), BOTH OF WHICH WILL BE HELD IN INDIANA. OUT OF STATE DISPUTE RESOLUTION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO RESOLVE A DISPUTE WITH US IN INDIANA THAN IN YOUR HOME STATE. ALL LEGAL ACTIONS MUST BE BROUGHT IN THE STATE OF INDIANA.

2. THE FRANCHISE AGREEMENT STATES THAT INDIANA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

3. THE AREA DEVELOPMENT PROGRAM INCLUDES A DISPUTE RESOLUTION PROVISION THAT USES THE CHURCH AND BIBLICAL PRINCIPLES AS ADMINISTERED BY THREE PASTORS, MINISTERS OR ELDERS, WHO MAY OR MAY NOT BE ATTORNEYS. UNDER THIS DISPUTE RESOLUTION PROCESS, EACH PARTY TO THE DISPUTE SELECTS A PASTOR, MINISTER OR CHURCH ELDER TO REPRESENT ITS INTERESTS IN THE DISPUTE. THE TWO PASTORS, MINISTERS OR ELDERS THEN SELECT A THIRD PASTOR, MINISTER OR ELDER. THIS PROCESS IS SIMILAR TO AN ARBITRATION PROCEEDING, WITH EACH SIDE PRESENTING ITS CASE TO THE THREE PASTORS, MINISTERS OR ELDER, WHO IN TURN RENDER A FINAL DECISION.

4. IN THE EVENT OF TERMINATION OR NON-RENEWAL, PAYMENTS DUE TO FRANCHISEE IN ANY AMOUNT MAY BE SUSPENDED UNTIL FRANCHISEE HAS FOLLOWED THE METHODS OF OPERATION IN FULL.

5. THE SPOUSE OF THE FRANCHISEE/AREA DEVELOPER OR THE SPOUSE OF ANY OWNER OF A FRANCHISEE/AREA DEVELOPER MUST SIGN A PERSONAL GUARANTEE MAKING SUCH SPOUSE JOINTLY AND SEVERALLY LIABLE FOR THE OBLIGATIONS UNDER THE FRANCHISE/AREA DEVELOPER AGREEMENT WHICH PLACES THEIR OWN ASSETS AT RISK.
