The franchise offered is for the operation of an **OFFICE PRIDE**® area developer franchise program which provides qualified individuals with the opportunity to recruit, develop and service single unit **OFFICE PRIDE**® franchises located in a specified trade area on our behalf.

The total investment necessary to begin operation of an area developer franchise is from \$158,400 to \$372,500. This includes \$50,000 to \$100,000 that must be paid to us.

This disclosure document summarizes certain provisions of your area developer agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however that no government agency has verified the information contained in this document.**

YOU MAY HAVE TO SIGN A NEW AGREEMENT WITH DIFFERENT TERMS AND CONDITIONS IN ORDER TO CONTINUE TO OPERATE YOUR BUSINESS. BEFORE YOU BUY, CONSIDER WHAT RIGHTS YOU HAVE TO RENEW YOUR FRANCHISE, IF ANY, AND WHAT TERMS YOU MIGHT HAVE TO ACCEPT IN ORDER TO RENEW.

Please consider the following RISK FACTORS before you buy this franchise:

- 1. THE AREA DEVELOPMENT PROGRAM INCLUDES A DISPUTE RESOLUTION PROVISION THAT USES THE CHURCH AND BIBLICAL PRINCIPLES AS ADMINISTERED BY THREE PASTORS, MINISTERS OR ELDERS, WHO MAY OR MAY NOT BE ATTORNEYS. UNDER THIS DISPUTE RESOLUTION PROCESS, EACH PARTY TO THE DISPUTE SELECTS A PASTOR, MINISTER OR CHURCH ELDER TO REPRESENT ITS INTERESTS IN THE DISPUTE. THE TWO PASTORS, MINISTERS OR ELDERS THEN SELECT A THIRD PASTOR, MINISTER OR ELDER. THIS PROCESS IS SIMILAR TO AN ARBITRATION PROCEEDING, WITH EACH SIDE PRESENTING ITS CASE TO THE THREE PASTORS, MINISTERS OR ELDER, WHO IN TURN RENDER A FINAL DECISION.
- 2. THE AREA DEVELOPMENT AGREEMENT STATES THAT INDIANA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. THE SPOUSE OF THE AREA DEVELOPER OR THE SPOUSE OF ANY OWNER OF AN AREA DEVELOPER MUST SIGN A CONFIDENTIALITY AND NON-COMPETE AGREEMENT.
- 4. AREA DEVELOPERS ARE REQUIRED TO MEET CERTAIN MINIMUM SALES REQUIREMENTS UNDER THE TERMS OF THEIR AREA DEVELOPER AGREEMENT. IF AN AREA DEVELOPER FAILS TO MEET ITS MINIMUM SALES REQUIREMENTS, WE MAY: (i) REDUCE OR WITHHOLD THE AREA DEVELOPER'S SHARED ROYALTY PAYMENT; (ii) REDUCE THE SIZE OF THE AREA DEVELOPER'S TRADE AREA; OR (iii) TERMINATE THE AREA DEVELOPER AGREEMENT.
- 5. YOUR SPOUSE MUST ALSO SIGN A PERSONAL GUARANTEE MAKING YOUR SPOUSE INDIVIDUALLY LIABLE FOR YOUR FINANCIAL OBLIGATIONS UNDER THE AGREEMENT. THE GUARANTEE WILL PLACE YOUR SPOUSE'S MARITAL AND PERSONAL ASSETS AT RISK IF YOUR FRANCHISE FAILS.
 - 6. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more franchise brokers or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
