We offer to grant you the right to operate an Oggı's™ Restaurant Your Restaurant will offer on-premises dining, carry-out and delivery for a wide variety of pizza, pasta, burgers, Italian-style and American-bistro food and other products, including micro brewed beer and other alcoholic beverages

- (1) The total investment necessary to begin operation of an Oggi's™ Restaurant is approximately \$1,000,000.00 to \$1,500,000.00. This includes an initial franchise fee of \$50,000.00 that must be paid to the Franchisor
- (2) If you sign a Multi-Franchise Development Agreement, you may develop up to three (3) franchise restaurants The Initial Franchise Fee for the first franchise is \$50,000 The Initial Franchise Fee for the second franchise is \$25,000 The Initial Franchise Fee for the third franchise is \$0.00. Upon signing the Multi-Franchise Development Agreement, you pay a lump sum, nonrefundable Development Fee equal to 100% of the Initial Franchise Fees
- (3) If you sign an Area Development Agreement, you must develop a minimum of three (3) franchise restaurants within the Development Territory. The Initial Franchise Fee for the first franchise is \$50,000. The Initial Franchise Fee for the second franchise is \$25,000. The Initial Franchise Fee for each additional franchise is \$12,500. Upon signing the Area Development Agreement, you pay a lump sum, nonrefundable Development Fee equal to one hundred percent (100%) of the Initial Franchise Fee for the first franchise to be developed and fifty percent (50%) of the Initial Franchise Fee for each subsequent franchise to be developed under this Area Development Agreement



- (4) This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the Franchisor in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
- (5) The terms of your contract will govern your franchise relationship Don't rely on the Disclosure Document alone to understand your contract Read your entire contract carefully Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant
