The remaining \$72,500.00 balance for the total Initial Franchise Fees is due to Franchisor upon signing the first Franchise Agreement with the Franchisor and the first lease agreement with the landlord for the first Authorized Location.
- (b) An initial non-refundable deposit is \$2,500.00 is due to Franchisor upon signing the Multi-Franchise Development Agreement for Oggi's Pizza Express® Restaurants. The remaining \$47,500.00 balance for the total Initial Franchise Fees is due to Franchisor upon signing the first Franchise Agreement with the Franchisor and the first lease agreement with the landlord for the first Authorized Location.
- (c) An initial non-refundable deposit of \$75,000 is due to Franchisor upon signing the Area Development Agreement for a minimum of three (3) Oggi'sTM Full-Service Restaurants. This non-refundable deposit includes the Initial Franchise Fee of \$50,000 for the first Oggi'sTM Full-Service Restaurant, and fifty percent (50%) of the Initial Franchise Fee of \$25,000 for each subsequent Oggi'sTM Full-Service Restaurant. The remaining fifty percent (50%) of the Initial Franchise Fee of \$25,000 for each subsequent Oggi'sTM Full-Service Restaurant shall be paid to Franchisor when the Franchise Agreement and lease agreement are signed for each subsequent Oggi'sTM Full-Service Restaurant.
