One Day Doors and Closets, Inc. ("One Day") offers franchises for the right to operate retail businesses that sell to both residential and commercial customers, customized interior and exterior doors, closet doors and closet organization products, and window covering products and related measuring, installation and support services.

The total investment necessary to begin operation of a One Day franchise is \$151,250 to \$307,000. This includes a minimum of \$40,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying exhibits carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

IT MAY ALSO COST YOU MORE TO ARBITRATE AND/OR MEDIATE WITH US IN CALIFORNIA THAN IN YOUR OWN STATE.

PREFACE

THE CALIFORNIA FRANCHISE INVESTMENT LAW REQUIRES THAT A COPY OF ALL PROPOSED AGREEMENTS RELATING TO THE SALE OF THE FRANCHISE BE DELIVERED TOGETHER WITH THE DISCLOSURE DOCUMENT.

The following information is disclosed in connection with Item 17:

California Business and Professions Code Sections 20000 through 20043 provide rights to the franchisee concerning termination or non-renewal of a franchise. If the franchise agreement contains a provision that is inconsistent with the law, the law will control.

The franchise agreement provides for termination upon bankruptcy. This provision may not be enforceable under federal bankruptcy law (11 U.S.C.A. Sec. 101 et seq.).

The franchise agreement contains a covenant not to compete which extends beyond the termination of the franchise. This provision may not be enforceable under California law.

The franchise agreement contains a liquidated damages clause. Under California Civil Code Section 1671, certain liquidated damages clauses are unenforceable.

The franchise agreement requires binding arbitration with respect to certain claims. The arbitration will occur at Los Angeles, California with the costs being borne by the prevailing party in the dispute.
