The licenses described in this franchise disclosure document are for the operation of a retail automotive Outlet using the name ONE STOP PARTS®, which features the sale of automobile parts, accessories and equipment to automobile repair and maintenance shops. The initial license fee is between \$40,000 to \$80,000. The estimated initial investment required ranges from \$574,000 to \$871,000.
