The total investment necessary to begin operation of a single One Week Bath Business is approximately \$117,575115.475 to \$201,125,164.525, which includes \$51,97551.875 that must be paid to us or our affiliate

Multiple One Week Bath Business Program
Under this program, you will agree to operate 2 – 3 One Week Bath Businesses in a defined geographic area within a specified period of time. The total investment necessary to begin operation of a multiple development franchise for 2 - 3 One Week Bath Businesses is approximately \$127,575125,475 to \$211,125174,525 per One Week Bath Business, which includes \$61,97561.875 that must be paid to us or our affiliate

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English—Read the Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payments to the Franchisor or its affiliate in connection with the proposed franchise sale.
