Franchisor franchises the right to own and operate businesses offering non-medical personal care and companion care services provided by certified nursing assistants, home health aides, personal care aides and companions to seniors and other adults with chronic or acute illnesses under the mark "One You Love Homecare."

The total investment necessary to begin operation of a One You Love Homecare Business is \$95,400 to \$169,800. This includes \$49,500800 to \$59,50060,850 that must be paid to Franchisor or its affiliates.

The total investment necessary to operate multiple One You Love Homecare Businesses under our form of area development agreement depends on the number of Businesses we grant you the right to develop. The total investment necessary to enter into a development agreement for the right to develop two (2) One You Love Homecare Businesses is \$134,900 to \$199,300, which includes a (a) development fee of \$89,000 that is paid to us, and (b) the total investment to open and commence operations of the initial One You Love Homecare Business. The minimum number of business you are required to develop under the Development Agreement is three (3). The total investment necessary to enter into a development agreement for the right to develop three (3) One You Love Homecare Businesses is \$174,400 to \$238,800 which includes (a) a development fee of \$128,500 that is paid to us, and (b) the total investment to open and commence operations of the initial One You Love Homecare Business.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
