The franchise offered by Financial Achievements Corporation is for the operation of a health and fitness center under the “Orange Shoe®” and “ORANGE SHOE PERSONAL FITNESS®” names that offers personal fitness training, classes, small group, and corporate wellness programs, in home training and individualized nutrition and weight loss counseling.

The total investment necessary to begin operation of an Orange Shoe franchise is from \$88,600 to \$315,000. This includes between \$31,000 and \$34,000 that must be paid to the franchisor. If you sign an Area Development Agreement, the total investment necessary is between \$118,600 and \$395,000 for each ORANGE SHOE PERSONAL FITNESS® Studio. This includes between \$61,000 and \$114,000 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
