ORGANIC BRONZE BAR

We are **OBB Franchising LLC**, an Oregon limited liability company. We offer franchises to qualified individuals to own and operate an **Organic Bronze Bar** franchise under the “**Organic Bronze Bar**®” names and logos. Collectively, these are called the “Service Marks.” Our franchisees offer studios that provide organic airbrush tanning - hand sprayed using a formula made with all natural and organic ingredients and no harmful chemicals - spa services; skin care products and other specialty items; with complementary products and services. These services and sales are offered to the public under the Service Marks (the “Method of Operation”).

The Initial Franchise Fee is **\$32,000**. In this disclosure document Organic Bronze Bar locations are called the “Studio.” You also must purchase from us or our affiliate or approved suppliers your initial and ongoing studio equipment, beauty treatment products, studio inventory and related materials and items needed for operation of your franchise. The total estimated initial investment necessary to begin operation of an Organic Bronze Bar franchise ranges from **\$167,900 to \$286,900**. Refer to Items 5, 6 and 7 of this Disclosure Document for a full explanation regarding the Initial Franchise Fee, other Fees and the Total Investment.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

OUT-OF-STATE LITIGATION AND MEDIATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO SUE OR MEDIATE WITH US IN OREGON THAN IN YOUR HOME STATE.
