As a franchisee, you will operate a salon offering spray and ultraviolet (UV) tanning solutions under the name Organic Shimmer<sup>®</sup>.

The total investment necessary to begin operation of an Organic Shimmer<sup>®</sup> salon is between \$110,900 and \$238,710. This includes between \$20,000 and \$32,500 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of an Organic Shimmer<sup>®</sup> Multi-Unit business is between \$118,400 and \$258,210. This includes between \$27,500 and \$62,750 that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. - 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
