An Oskar's Sausage Grill franchisee will operate a mobile grill or a grill at a permanent location featuring sausages, potato pancakes and other food and beverage items.

The total investment to begin operation of an Oskar's Sausage Grill mobile grill is \$85.000 to \$118,500 and to open a fixed-location Oskar's Sausage Grill is \$129,000 to \$206,000 including the initial franchise fee. This includes the initial franchise fee of \$25,000.00 that must be paid to the franchisor for each franchise to be operated at a fixed location and \$20,000.00 for each franchise to be operated as a mobile grill.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
