You will operate a wellness center ("Center") that offers customers the use of certain health and exercise equipment, including a machine which promotes bone and muscle health (the "bioDensity" machine") and a vibration plate exercise machine under the "OsteoStrong" trademarks and System.

The total investment necessary to begin operation of an OsteoStrong<sup>™</sup> Center ranges from \$89,370 to \$155,650. This includes the \$64,400 to \$68,400 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payments to, the franchisor or an affiliate in connection with the proposed franchise sale.
