The franchise offered is for the operation of a business under the *Our Town America* logo that sells to local businesses personalized direct mail marketing services and products that promote the businesses' services and products to certain consumers.

The total investment necessary to begin operation of a unit franchise operated under the *Our Town America* logo ranges from \$63,840 to \$86,250, but the low estimate excludes the cost of real estate and improvements. This includes \$48,040 that must be paid to us.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.

- (1) THE MARKET AREA IS NOT EXCLUSIVE. FAILURE TO ACHIEVE PERFORMANCE STANDARDS MAY LEAD TO TERMINATION OF THE FRANCHISE AGREEMENT.
- (2) THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY MEDIATION/ARBITRATION/LITIGATION ONLY IN FLORIDA. OUT OF STATE MEDIATION/ARBITRATION/LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE/LITIGATE WITH US IN FLORIDA THAN IN YOUR OWN STATE.
- (3) THE FRANCHISE AGREEMENT STATES THAT FLORIDA LAW GOVERNS THE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- (4) THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
