The franchised business is to operate a children's play center and entertainment business under the trade name "Time Out N Play"

The total investment necessary to begin operation of a Time Out N Play franchise is \$138,000 to \$242,000 This includes \$30,000 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation under a three- to five-unit Multi-Unit Development Agreement (including the first unit) is \$179,000 to \$327,000. This includes \$70,000 to \$110,000 that must be paid to the franchisor. There is no minimum number of Time Out N Play units that you are required to develop under the Multi-Unit Development Agreement.
