The total investment necessary to begin operation of an Outback Steakhouse restaurant ranges from \$2,394,500 to \$5,335,500. This includes \$131,500 to \$145,000 that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
