As a franchisee, you will operate a franchise offering cake decorating instruction along with the sale of related products and supplies, as well as cake decorating classes, camps, parties and events for children and adults under the name, "Over the Top Cake Supplies."

The total investment necessary to begin operation of a Over the Top Cake Supplies franchise is from \$120,250 to \$174,500. This includes \$50,000 to \$55,000 that must be paid to us as the franchisor or our affiliate. Please see Items 5 and 7 for additional details.

We may offer to enter into an area development agreement to establish and operate a certain number of Over the Top Cake Supplies franchises at specific locations pursuant to individual franchise agreements. The area development fee will be equal to \$10,000 multiplied by the number of Over the Top Cake Supplies franchises to be developed under the area development agreement. The area development fee will then be credited, in increments of \$10,000, toward the franchise fee owed for each Over the Top Cake Supplies franchise developed. Your estimated initial investment will vary based on the number of stores to be developed.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive the Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

You may wish to receive your Disclosure Document in another format that is more convenient for you.
