As a franchisee, you will operate a full-service specialty retail store featuring an extensive selection of batteries, including custom-built batteries and power accessories and offering installation services.

The initial franchise fee is \$35,000. The estimated initial investment ranges from \$116,625 to \$162,283.

RISK FACTORS:

- 1. THE FRANCHISE AGREEMENT REQUIRES THAT CERTAIN DISAGREEMENTS BE MEDIATED OR ARBITRATED (OR LITIGATED, IN CERTAIN INSTANCES) IN SNOHOMISH COUNTY, WASHINGTON. OUT OF STATE MEDIATION, ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE OR LITIGATE WITH US IN WASHINGTON THAN IN YOUR HOME STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT WASHINGTON LAW GOVERNS THE AGREEMENT; HOWEVER, WASHINGTON LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS YOUR STATE'S LAW. YOU MAY WANT TO COMPARE THESE LAWS. SOME STATE FRANCHISE LAWS PROVIDE THAT CHOICE OF LAW PROVISIONS ARE VOID OR SUPERSEDED. YOU MIGHT WANT TO INVESTIGATE WHETHER YOUR STATE HAS FRANCHISE LAWS THAT PROTECT YOU. YOU SHOULD REVIEW THE ADDENDA ATTACHED TO THIS OFFERING CIRCULAR AND THE FRANCHISE AGREEMENT FOR STATE SPECIFIC PROVISIONS.
- 3. EVEN THOUGH THE FRANCHISE AGREEMENT PROVIDES THAT WASHINGTON LAW APPLIES, LOCAL LAW MAY SUPERSEDE IT IN YOUR STATE. PLEASE REFER TO ANY STATE SPECIFIC ADDENDUM THAT MAY BE ATTACHED TO THE OFFERING CIRCULAR FOR DETAILS.
- 4. THE FRANCHISOR ONLY RECENTLY BEGAN OFFERING FRANCHISES AND HAS NO HISTORY OF FRANCHISE OPERATIONS. YOU MAY WANT TO CONSIDER THIS IN DECIDING WHETHER TO PURCHASE A FRANCHISE.
- 5. OUR APPLICATION FOR A FEDERAL TRADEMARK REGISTRATION FOR THE NAME/MARK "PACIFIC POWER BATTERIES" IS PENDING. BY NOT HAVING A PRINCIPAL REGISTER FEDERAL REGISTRATION FOR THE MARK "PACIFIC POWER BATTERIES," WE DO NOT HAVE CERTAIN PRESUMPTIVE LEGAL RIGHTS GRANTED BY A REGISTRATION.
- 6. EVEN THOUGH THE FRANCHISE AGREEMENT PROVIDES THAT WASHINGTON LAW APPLIES, LOCAL LAW MAY SUPERSEDE IT IN YOUR STATE. PLEASE REFER TO ANY STATE SPECIFIC ADDENDUM THAT MAY BE ATTACHED TO THE OFFERING CIRCULAR FOR DETAILS.



7. THE FRANCHISOR HAS BEEN IN EXISTENCE FOR A SHORT PERIOD OF TIME, SINCE SEPTEMBER 6, 2005. THEREFORE, THERE IS ONLY A BRIEF OPERATING HISTORY TO ASSIST YOU IN JUDGING WHETHER OR NOT TO MAKE AN INVESTMENT IN A FRANCHISE.

THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
