The total investment necessary to begin operation of a Padgett franchise is \$99,835.00. This includes \$56,000.00 that must be paid to the franchisor or affiliate.

1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY LITIGATION ONLY IN MASSACHUSETTS. OUT-OF-STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE WITH US IN MASSACHUSETTS THAN IN YOUR OWN STATE.

ALSO, A GUARANTOR PLACES HIS OR HER PERSONAL ASSETS AT RISK BY PERSONALLY GUARANTEEING THE FRANCHISEE'S OBLIGATIONS.
4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

WE USE THE SERVICES OF ONE OR MORE FRANCHISE BROKERS OR REFERRAL SOURCES TO ASSIST US IN SELLING OUR FRANCHISE. A FRANCHISE BROKER OR REFERRAL SOURCE REPRESENTS US, NOT YOU.
