Pak Mail Centers of America, Inc., a Colorado corporation, is offering franchises to "Area Marketers," giving them the right to <u>develop and market PAK MAIL</u> Center franchises and to provide services to existing Pak Mail franchisees within a specific territory.

The total estimated initial investment necessary to begin operation of a Pak Mail Area Marketer franchise, ranges from \$26,965 to \$326,565. This includes \$24,000 to \$300,000 that typically must be paid to the franchisor, although the high range may be higher depending on the population of the Territory. The initial fee is calculated by multiplying the population of the Territory by a price per person which ranges from \$0.05 to \$0.10 per person. The total estimated initial investment to begin operation of a Pak Mail Area Marketer franchise, including the initial fee, ranges from \$26,965 to \$326,565. See Items 5, 6 and 7.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. - 4. THE AREA MARKETING AGREEMENT REQUIRES YOU TO MEET MINIMUM SALES <u>AND DEVELOPMENT</u> GOALS WHICH, IF NOT MET, MAY RESULT IN THE TERMINATION OF THE AGREEMENT OR THE LOSS OF YOUR RIGHT TO ACT AS AN AREA MARKETER IN YOUR TERRITORY.
- 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We reserve the right to use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source is our agent and represents us, and not you. We pay this person a fee for selling our franchise or referring you to us.
