Pak Mail Centers of America, Inc., a Colorado corporation, is offering franchises for the operation of a business which offers a variety of packaging, shipping, mailing, communications and information products and services.

The total estimated initial investment necessary to begin operation of a Pak Mail franchise ranges from \$133,890 to \$180,160. This includes \$105,390 to \$116,160 that must be paid to the franchisor. See Items 5, 6 and 7.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
