The franchise is for a PANCHERO'S® restaurant featuring burritos, quesadillas, tacos, burrito bowls, salads, rice, salsa, and other food and beverage products.

The total investment necessary to begin operation of a PANCHERO'S® franchise ranges from \$344,775 to \$766,040 (including initial real estate lease costs). This includes the \$30,000 initial franchise fee if you develop a single Franchised Restaurant, or the \$20,000 initial franchisee fee if you develop multiple Franchised Restaurants under an Area Development Agreement. If you acquire development rights you will sign our Area Development Agreement and, upon signing, you will pay us a development fee equal to 100% of the first initial franchise fee due for the first Franchised Restaurant and 50% of the initial franchise fee due for each additional Franchised Restaurant you commit to develop.

This disclosure document summarizes certain provisions of your franchise agreement and area development agreement, as well as other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendardays before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

You may wish to receive your disclosure document in another format that is more convenient for you.
