As a franchisee, you will operate a Papa Murphy's retail food outlet currently featuring take and bake pizza, fresh calzones, pastas, salads, desserts and other related products ("Franchised Store").

The total investment necessary to begin operation of a Papa Murphy's Franchised Store is from \$274,620 to \$499,246. This includes \$153,000 to \$210,445 that must be paid to us or our affiliates of which \$25,000 is the "Franchise Fee."

If you sign an Area Development Agreement and pay an Area Development Fee, you will pay a reduced Franchise Fee of \$0 to \$10,000 for all stores (other than the first store) developed under the Area Development Agreement.

If you participate in our optional Pre-Sale Development Program, the total investment necessary to begin operation of a Papa Murphy's Franchised Store is from \$287,620 to \$521,246. This includes \$25,000 to \$395,345 that must be paid to us or our affiliates.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale or grant. **Note, however, that no governmental agency has verified the information contained in this document.**

You may wish to receive your Disclosure Document in another format that is more convenient for you.
