As a franchisee, you will operate a PAPA SAVERIO'S restaurant featuring pizza and other food items.

The total investment necessary to begin operation of a PAPA SAVERIO'S restaurant ranges from \$134,200 to \$343,500 for a carryout/delivery location and from \$257,500 to \$975,500 for a sit-down restaurant. This includes \$25,000 that must be paid to the franchisor or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
